DUPLICATION AGREEMENT**

**I would like to make duplications/reproductions of materials in the ABHS collection described on the reverse side of this agreement. I understand that, in accepting this service, I agree to the following conditions:**

1. Reproduction of archival and library materials are **for use only in research and private study** by the applicant. **Copies may not be reproduced in full or in part with written permission from ABHS.** The applicant, without prior written consent of ABHS, may not place copies at other repositories.

2. **Offsite researchers seeking duplication of ABHS materials must request those materials through the ABHS Research-by-Mail service.** Research by Mail fees, charged by the hour, cover staff labor costs connected with locating the appropriate collection materials. Duplication fees are in addition to the research-by-mail charges. **Duplication fees for Onsite researchers are in addition to day-use reading room charges.** The applicant agrees to pay the full cost of copies ordered, including labor charges, postage and handling, and other charges, as applicable.

3. ABHS reserves the right to: 1) refuse to copy any item that may be damaged by the reproduction process; 2) refuse to copy items that are restricted by copyright; 3) Limit the number of photographic copies, photocopies, or scans; 4) charge different fees than those currently published by ABHS.

4. With the approval of ABHS archival staff, onsite patrons may make their own copies with personal scanners or cameras. ABHS staff must approve the scanning/photography equipment, as well as the collection materials to be scanned.

5. Excerpts from copyrighted materials may not be quoted by the applicant in his or her own work or elsewhere without permission of the copyright holder, except as allowed under the fair use guidelines of the copyright law (Title 17, USC). Reproduction of complete unpublished or copyrighted published works (whether in an article, book, film, website, etc.) requires permission of the copyright holder. The applicant is responsible for obtaining this permission prior to publication. In addition, **if the applicant wishes to publish from manuscript or archival materials held in ABHS, written permission must also be secured from the Archivist or Director. Contact ABHS for more information on how to request permission to publish ABHS collection materials.**

6. The applicant agrees to indemnify and hold harmless the American Baptist Historical Societies, its officers, employees and agents from and against all suits, claims, actions and expenses arising out of the use of reproductions provided by the ABHS.

## American Baptist Historical Society Duplication Fees

Listed below are the fees for duplicating materials from the American Baptist Historical Society (ABHS) collections. Charges are subject to change without notice. Some circumstances may change the cost of reproduction, so please check with staff to receive an estimate of cost prior to duplication.

Reproduction of collection formats not listed here, e.g., audiovisuals, may be possible; see staff to negotiate details. Some resources cannot be duplicated. ***Fees listed here pertain only to materials reproduced for personal research use only. They are in addition to charges for our research by mail service and do not include permission fees required to publish the materials.*** Additional fees may be required for invoicing, packaging and shipping, and rush orders.

### Photocopies

Photocopies by library staff only. Please allow up to two weeks for service and delivery.

- Letter/legal-sized copy \$0.50
- Ledger-sized copy \$0.75
- Surcharge for large orders \$10.00 per 100 copies
- Surcharge for rush orders \$10.00
- Surcharge for postage and packaging See staff

### Microfilm Reader/Printer

Under special circumstances, microfilm reels may be duplicated. See staff for conditions and charges

- Printed by on-site patrons \$0.50 per copy
- Offsite request \$0.50 per copy

### Scans by Researchers

Personal scanning/photography equipment, as well as materials to be scanned, must be approved by staff. ABHS reserves the right to set limits on the amount of copying undertaken.

- Daily fee – flat rate \$15.00

### Scans by Staff

Photographs and fragile materials must be scanned by staff. Scanned materials can be emailed for no additional fee. Note that digital reproductions may not be published in any form without written permission by ABHS.

- Scanned to pdf \$2.00 per scan
- Scan resolution suitable for personal research use \$5.00 per scan
- Scan resolution suitable for publishing \$40.00 per scan
- Surcharge to scan images to CD \$10.00 per CD
